The Stewards have received a petition from the Driver/Competitor Sabré COOK for them to review, in accordance with Art. 14.1.1 of the FIA International Sporting Code, the decision#3 taken by the Stewards during the Round#1 of the W Series held during the Formula 1 BTW Grosser Preis der Steiermark:

No. / Driver: 37 / Sabré COOK

Competitor: Sabré COOK

Date&Time (fact): Saturday 26 June 2021 / 17:00 hrs

Session: Race

Fact: On Saturday 26 June 2021, car#37 had been reported to the Stewards having made a contact into the rear of car#97 at T#3 causing car#97 to spin off the circuit (log#22). Having considered the matter extensively and after having conducted a full investigation, the Stewards had decided to apply a drop of three grid positions for the next race in which the Driver/Competitor Sabré COOK will participate (log#23).

This decision had been notified to Sabré COOK on Saturday 26 June 2021 at 18:35.

On Thursday 1 July 2021, the Stewards have received a new report from the Race Director (log#35) with new evidence proving that Sabré COOK was clearly not at fault.

Regulation: Alleged breach of Art. 24.2d) of the W Series Sporting Regulations and Art. 14.1.1 & Art. 14.3 of the FIA International Sporting Code

Decision: Decision#3 taken by the Stewards on Saturday 26 June 2021 at 18:30 is cancelled

Reason: In accordance with Art. 14.1.1 of the FIA International Sporting Code, it is up to the Stewards to re-examine or not their decision following a petition of review. After a second investigation based on the new report sent by the Race Director and after having heard all relevant explanations, the Stewards have considered that a significant and new element has been discovered which was unavailable when the Decision#3 was taken by the Stewards in accordance with Art. 14.3 of the FIA International Sporting Code. Therefore the Stewards have considered that the cancellation of the Decision#3 is appropriate in that case.

Competitors are reminded that they have the right to appeal certain decision of the Stewards in accordance with Art. 27.2/27.3 of the W Series Sporting Regulations, Art. 15 of the FIA International Sporting Code and Article 9.1.1 of the FIA Judicial and Disciplinary Rules, within the applicable time limits.
